**Public Comments**

- Nathan Hanson, White Lake Superintendent-March 8 the Langlade County Sheriff Dept will be at school doing training all day. There is no school that day for students.
- Ron Kaas spoke on information on the Pelican River Forest and asked the board to consider approving a resolution, at a future meeting, to support this program.

**New Business**

- Nathan Hanson and Amanda Hatch presents a draft of the itinerary for the “White Lake School 100 Years of Graduations Celebration”. This event will take place on Saturday, May 27, 2023 with a meet & greet at school from 10:30am-1:00pm then moving to the White Lake Historical Society and attached land behind historical society from 1:00pm-9:00pm. Small sections of road on Lake Street and Anderegg Streets that surround historical society will be closed to through traffic that day.
- State of WI is offering a program for one time water/sewer payments to residents that are behind on their bills. It is free for the Village to sign up. The Low Income Household Water Assistance Program (LIHWAP) will be one more way to prevent overdue bills from possibly going on property tax bills. Motion way made by Edelman/Listle to accept the Contract for services between the State of WI, Dept of Administration and the Village of White Lake to accept payments from the LIHWAP Program for past due water/sewer payments; All Ayes, Motion Carried.

There will be no cost to the Village. Patsy will be doing the project with Matt Holbrook and possibly getting remanent flooring from the mill to complete the project. It is scheduled to start Wednesday, February 15.
