Unfinished Business

- MSA Project Updates-CDBG-CV Park Project-working on finishing and punch list items, should receive notification on Sport Fishing Grant later this month, we will start working on Capital Improvement Plan again soon, TID has new laws for exempt personal property that we have until 2024 to complete, & we should hear if we get the emergency FEMA Grant for the generators at the community center and fire department within a month or two.
- Furnace/AC Quotes for Community Center-2 estimates were received; one from Simmons Heating for \$10,000 and one from Jerome's Heating for \$7,000. A Motion was made by Listle/Skarlupka to hire Jerome's Heating to install a new furnace and AC unit for the White Lake Community Center in November 2023 for \$7,000; All Ayes, Motion Carried.
- High School Office Assistant/Work Study Program-Discussion held, Patsy Listle agreed to help with the interview process with Clerk-treasurer, Carol Blawat. Motion by Skarlupka/Listle to approve hiring a high school student to work with clerk-treasurer in the village office as an office assistant as part of the work study program with White Lake School for up to 10-20 hours per week, as determined by clerk-treasurer, at an hourly rate of \$10 hourly; All Ayes, Motion Carried.
- Village Fee Schedule & Permit Applications-Motion by Listle/Skarlupka to accept Village Fee Schedule and Permit Applications with discussed updated as presented; All Ayes, Motion Carried.

New Business

- Waste Management-Discussion on recycling going to every other week. The board discussion was that it would be too confusing for residents and with no cost saving offered to the village from Waste Management, the board did not make any motions to change the service. Service should remain weekly pickup.
- FFP Grant Award-White Lake Fire Dept was awarded the FFP Grant for 2023. They will be getting an AED and a chainsaw for the ladder truck. This DNR Grant is a 50/50 grant and will reimburse the fire department \$1241.50.

Each municipality will receive just under \$35,000.
